## SECTION II — PURPOSE OF AGREEMENT

This **Covenant Partnership Agreement** establishes a formal relationship between the **New World International Institute (NWII)** and the partnering **Church**, for the purpose of:

- Advancing global healing, unity, and doctrinal integrity
- Strengthening spiritual governance and leadership development

- Collaborating in education, research, and mission initiatives
- Aligning with the Word of God as the supreme standard
- Participating in the global movement for reconciliation and transformation

## **SECTION III — SCOPE OF PARTNERSHIP**

### **A. Areas of Collaboration**

The Church agrees to collaborate with NWII in one or more of the following:

- **Ministerial Training & Certification**
- **Theological Research & Publications**
- **Pastoral Development & Governance**
- **Environmental & Healing Missions**
- **Interfaith Unity & Peacebuilding**
- **Community Development & Social Impact**
- **Academic Programs & Institutional Exchange**

### **B. NWII Commitments**

NWII agrees to:

- Provide spiritual covering and apostolic oversight as appropriate
- Offer access to NWII educational programs, conferences, and research
- Support leadership development and doctrinal strengthening
- Facilitate global networking with aligned institutions
- Uphold the integrity of the Word of God in all guidance

### **C. Church Commitments**

The Church agrees to:

- Uphold biblical doctrine consistent with NWII's standards
- Participate in NWII programs, training, and alignment reviews
- Maintain ethical governance and financial integrity
- Support collaborative mission initiatives
- Promote unity, healing, and reconciliation in its region

## SECTION IV — DOCTRINAL ALIGNMENT

The Church affirms agreement with the following:

- The Word of God is the final authority
- Christ Jesus is the Head of the Church and the true Chancellor of NWII
- The mission of God includes healing nations, restoring creation, and unifying believers
- Evil is to be resisted, exposed, and overcome through truth and righteousness

### Doctrinal Alignment Level:

- Full Alignment
- Partial Alignment (seeking full alignment)
- Under Review

## SECTION V — TERM & RENEWAL

- This Agreement becomes effective upon signature by both parties.
- The term is **3 years**, automatically renewable unless terminated in writing.
- Either party may request review or amendment at any time.

## SECTION VI — CONFIDENTIALITY & CONDUCT

Both parties agree to:

- Maintain confidentiality of sensitive information
- Conduct all activities with integrity, transparency, and accountability
- Avoid actions that bring dishonor to Christ Jesus or the partnership

## SECTION VII — TERMINATION

This Agreement may be terminated if:

- Doctrinal deviation occurs
- Ethical or legal violations arise
- The Church or NWII requests release from covenant partnership

Termination does not negate the spiritual commitment to unity and peace.
